LAW SCHOOL COURSES DEVELOPED AND TAUGHT

Legal Research and Writing I LAW 514 focuses on instruction in foundational concepts of state

legal research and objective, predictive writing. Students learn to find, read, and understand cases and statutes to assemble the legal basis for their analysis. Students meet individually with the professor frequently throughout the semester and are assessed to

monitor mastery of analytical and writing skills.

Legal Research and Writing II LAW 515 focuses on instruction in foundational concepts of

federal legal research and persuasive writing. Students meet individually with the professor frequently throughout the semester to assess and discuss progress on various memos,

motions, and briefs.

Advanced Legal Writing LAW 712 focuses on developing advanced persuasive legal

writing skills by introducing and exploring innovative approaches

to argument and document design.

Law and Film LAW 744 explores the intersection of law and popular culture by

using law-themed films as texts. Students study the cultivation effect to uncover the relationship between popular images of

lawyers and law practice and their influence on public perceptions of the field. Short writing assignments throughout the course culminate with a major paper and presentation.

Contracts Drafting and Negotiation

LAW 590 introduces the fundamentals of contract drafting and skills in a concentrated, two-week format.

Council on Legal Education Opportunity Summer Institute: Introduction to Legal Analysis and Writing This course focuses on fundamental concepts critical to thorough legal analysis and was developed to prepare admitted law students from across the country for the rigors of a typical first-year curriculum before they begin law school.

EDHE 670/770 focuses on written and oral communication in the higher education workplace. Students draft cover letters, memos, reports, and job descriptions. Students deliver oral presentations on selected topics.
