## --Gift Announcement & Renaming of the UK College of Law

In December 2019, a \$20 million gift commitment from alumnus J. David Rosenberg and his wife, Dianne, the third largest in university history, created an endowment to enhance the intellectual excellence and promise of the College of Law, which has officially been renamed the University of Kentucky J. David Rosenberg College of Law.

#### The Rosenberg College of Law Endowment will:

- Provide merit schlarships annually, creating J. David Rosenberg Scholars.
- Support faculty positions with funding of salary enhancement and assistance with national and internally important research.
- Support college program needs including symposia of national or international important.
