

Helpful Hints for Registration

- Clinics- will send over a list of which students should be registered in each clinic. Once we receive this list, we will register those students
- Co-curricular- The designee for each co-curricular sends us a list of who should be registered and if they should be registered to receive credit and if they will audit the course.
- 16th hour- If you register for more than 15 hours, you will receive additional charges on the 16th hour.
- Tuition per hour is \$867 for resident and \$1870.25 per hour for Non-resident

- Be sure to select the appropriate Law drop down and Residency status drop downs

Blackboard Survey

Make sure you complete the survey in Blackboard.

- You should be able to click on [Fall 2022](#), click Begin in the bottom right corner and you will see 4 questions
- **Question 1-**You agree to not work more than 20 hours a week or participate if you are enrolled in 13 or more hours including co-curriculars **if you answer yes you will need to contact Dean Cooper [-bcooper@olemiss.edu](mailto:bcooper@olemiss.edu)**
- **Question 2-**Is there any character and fitness information you need to report, **if yes, contact Dean Barbee- bebarbee@olemiss.edu**

- **Question 3-** is simply you name (last, and first)
- **Question 4-** is your student ID number

Time Windows

Your time windows should now be set based on the posted Registration time windows you received a link to.

- If your time window does not reflect your accommodated status, you may need to **contact Dean Barbee (bebarbee@olemiss.edu) to make sure that information has been approved**

Evaluations

- Completion of 100% Evaluations gives students the enhanced time window by 1 day earlier. These evaluations are the evaluations you completed at the end of the prior semester. It is TOO Late now to complete Evaluations to receive the enhanced time window for Fall 2022.
- On the academic calendar you will see that there are two different periods to submit your evaluations.
- For the next Priority Registration cycle you will complete your evaluations at the end of Spring.
- The first period to complete your evaluation is
- Phase I - April 17-April 22
- Phase II -May 6-May 19th
- Evaluations completed in Phase I receive the enhanced time window during the Priority Registration for Winter/Spring 2023 and ability to view their grades early during the current term
- Evaluations completed during Phase 2 only receive the ability to view their grades early at the end of the current term
